## Outcomes from the A.G.M.

The major outcome from the 2010 AGM is the restructuring of the NZISA to a governance and management structure that includes a 5 member board, and Operations group and a Development group. More information regarding the structure, job descriptions and the transition from the current structure to the new structure will be out over the next few months.

Minutes from the NZISA Council and Technical Committees will now be available to all members no later than 28 days after the meeting of each group. It needs to be remembered that the minutes are provisional until they are accepted as a true and accurate account by the respective committees. Amendments to the minutes can only be made by people who have attended the meetings.

NZISA website forums – the remit to have these reinstated was not carried, however, the Council agreed to look at this issue again which it did at its meeting on 25 April. At this time, a forum for dissemination of and submissions on Rules and Regulations will be put up so that draft Rules and Regulations are available for all NZ Skating Community members to view and/or submit changes. All submissions to the Rules and Regulations forums as well as the Policy submissions forum, need to be in the format as they would appear in the Rules or Policy document. A short rationale can also be posted to explain the thinking behind the submission.

Council will continue to discuss the reinstatement of the forums and the parameters regarding the accept-

able use of these forums.



## Madelaine Parker Competes in Italy



Madelaine Parker (Centaurus ISC) recently competed at the Gardena Spring Trophy in Selva del Gardena, Italy. Madelaine was accom-

panied by her father, Garry, and her coach, Kim Lewis. Madelaine placed 10<sup>th</sup> out of 19 in the Short Program and 17<sup>th</sup> out of 19 in the Free Skate to be 17<sup>th</sup> overall. A very good effort for her first overseas international event!



## Obituary—Gwen Le Compte

The NZISA Council sadly inform the NZ Skating Community that Gwen Le Compte, a former coach and judge, recently passed away in Brisbane. The following obituary was put together by some of Gwen's former pupils:

Gwen Jones, as she was known then, came to Christchurch in 1953 to coach at the newly opened Centaurus Ice Skating rink situated at the foot of Cashmere Hills. A Gold Medallist in singles and Silver Medallist in Dance from Australia, she was the first coach to come to Christchurch and was responsible for the improvement of skating in New Zealand. Many of her pupils became household names attracting large audiences to standing room only at championships. Her pupils, some of whom became personal friends, ranged from beginners up to Senior National Champions.

She put on many successful ice

shows in Christchurch also taking them to outdoor skating rinks in Central Otago further promoting ice skating. These shows were put together on the concrete floor of the ice rink prior to the ice being laid for the opening of the new skating season. In 1965 Gwen and fellow Coach Kath Craven took a group of skaters to Wellington



staging an ice show at the newly opened Ice Rink.

Many of the outdoor ice rinks in the South Island were visited by Gwen and her skaters competing in local, regional and National Championships. At

one of these championships it is reported it was so cold that the music turntable would not turn so she kept it turning with her finger.

In 1975 an invite was received from Australia for a team of NZ skaters to compete unofficially at the Australian Championships. Gwen accompanied ten of her skaters who competed in Singles, Pairs and Dance.

Gwen was named Administrator of the Year in 1975. After a long and successful career as a Coach Gwen regained her Amateur Status and turned her hand to judging.

Her daughter Gay achieved the Gold Medal Test in Figures and Freeskating in 1974 and represented NZ at the World Figure Skating Championships.

Some of her former pupils remain actively involved in skating today.

## Allie Rout Retires from Competitive Skating



It is with regret that the NZISA Council announces that Allie Rout has decided to retire from competitive skating, effective immediately.

Allie has represented New Zealand well at numerous international competitions and World Championships. She was the first NZ female skater to represent NZ at a Junior Grand Prix event. Her excellent results

brought her to the attention of the ISU and she was recognised for her efforts by twice being awarded an ISU scholarship. Allie was the inaugural winner of the Norman Cameron Cup of Excellence.

She is currently the NZ Junior and Senior Ladies Champion.

Allie is currently enrolled in the International Baccalaureate programme through St Kentigerns College and is looking to pursue a career in medicine in the

future.

On behalf of the NZ Skating Community, we would like to wish Allie well for whatever the future holds for her and to thank her for her contribution to skating in NZ and representing NZ so well in Australia and internationally.




## New Zealand Synchronized Skating Team 2010

Team New Zealand proudly represented New Zealand at the 2010 World Synchronized Skating Championships in Colorado Springs, USA, on 9 – 10 April. The atmosphere was electric and New Zealand competed against the best from 17 other countries. The team placed 23<sup>rd</sup> overall with a combined score of 61.84. Congratulations to all of the team members, to the coach, Robi Chalmers, the team manager, Heather McDonald and the team leader, Kevin Poit, on a super effort. Finland proved to be the powerhouse of Synchronized Skating this year; taking first and second overall, with the USA taking the bronze medal and Canada taking 4<sup>th</sup> and 5<sup>th</sup> places. This should prove to be interesting as the 2011 World Championships are to be held in Finland!
