Dunedin Dance Team in Russia

The Dunedin Ice Dance Team of Anne-Sophie and Dominic Shogimen trained in Russia during April. Whilst they were there they took part in a national competition for ice dance and were competing against the best ice dancers in Russia in their division. They placed 16/19 in the compulsory dance (Foxtrot) section and were placed 17/19 overall. A great result and, according to them, a very enjoyable and worthwhile experience.

Debts owed to the NZISA

Also at the AGM there was some concern expressed by the delegates at the level of debt that was owed to the NZISA. Due to some hard work on behalf of Liz Speden, our Treasurer most of this has now been paid. However, it has raised a concern within Councillors and members of the skating community.

The Council would like to draw your attention to the last paragraph in Clause 8 of the Finance Policy: "Members, including TC registered skaters, coaches, clubs and sub-associations, shall make payment to the NZISA by the 20th of the month following the month an invoice from the NZISA was received. Where payment is 90 days overdue, and where at least one statement has been sent via email, and it has been at least 30 days since a statement was sent to the physical address, the member shall be deemed to be "not in good standing with the NZISA".

To be deemed "not in good standing"

is a serious matter within any Club/ organisation. The NZISA could resort to several measures to recover these debts including passing them on to a debt recovery service and stopping the member concerned from having any involvement with skating until the debt is paid.

If you are one of our members who still have a debt outstanding to the NZISA please contact our treasurer straight away to make arrangements for payment and prevent this from happening to you.

It will include time on ice so the skaters could present their programmes to a Senior Judge and Technical Controller. These programmes would be videoed so that in off ice sessions the programmes could be discussed and possible improvements suggested. A registration fee of \$25.00 will be charged. Separate times will be booked to cover Synchronised and Dance seminars.

NEW ZEALAND SYNCHRONISED TEAM

Congratulations to Team New Zealand for performing creditably at the World Championships in Zagreb. It was great to receive the letter from the ISU congratulating New Zealand for sending a team. It proves what great ambassadors' the Team were for our skating community!!

We are now looking to the 2010 Team which will be going to Colorado Springs, USA, in April 2010. The NZISA have already called for expressions of interest from coaches for this team and will soon be putting out a call for

interest from skaters and manager/s. This will detail the requirements and expectations you will need to be a member of Team New Zealand.

One of the requirements already decided is that skaters will need to hold the inter-silver stroking test or intersilver dance test by the Friday 11

September 2009 which is the closing date for the NZ National entries.

Auditions will be held in at the Auckland Club Championships on either 11/12 July and at the South Island Championship on Saturday 25th July. There will be an audition fee of \$150.00. If you are selected this will go towards your costs. If you are not selected you will be refunded \$125.00.

The inaugural Team New Zealand was a big learning curve for the skaters and for the NZISA. We are still working through the reports from the current Team New Zealand Members hope to issue a report shortly.
